Becker Review Course Grant Fact Sheet

If you are/were an outstanding accounting student and leader, you are eligible to apply for the Kentucky Society of Certified Public Accountants Educational Foundation Becker Grants. The Foundation awards five full Becker CPA Review Course Grants to be presented each year. The grants recognize scholastic achievement and leadership qualities, as well as financial need, in students who plan to become CPAs.

To be eligible for the grants, applicants must:

- Be enrolled in a Kentucky college or university and be at least a senior at the time of application **OR** be employed at a KY employer,
- Be a Member of the KyCPA (Student Membership acceptable),
- Have an overall grade point average of at least 2.75 and an accounting grade point average of 3.0.

To apply for the grants, applicants should submit the following attachments (Please do not staple any part of this application with attachments or print on the backside of any document included):

- An official application form
- College transcript(s) (Copies or printed school website transcripts acceptable)
- A one-page essay stating career goals, reasons for choosing accounting, how you financed your education (including current employment info. with average number of hours worked/week) and why you should receive this grant
- Two letters of recommendation, one of which must be from an accounting faculty member or your current employer
- A current resume

All applications must be postmarked on or before January 31.

Winners will be notified by March 30. The grants will be presented at the Kentucky Society of CPAs Spring Awards Banquet.
